Open Forum

The Chairman Cllr.H.Collerson opened the meeting welcoming all attendees, and apologised for missing the last couple of meetings, and also pointed out that Mr.T.Sharples may attend the meeting to give the latest update on the scout filed.

Mr.Sharples joined the meeting and gave a presentation on the latest developments on the scout field scenario and the potential extension to the playing field lease. Mr.Sharples noted that the local village strategy for Stockton as laid down in the core strategy (unadopted as yet) Stockton would appear to have met its planning obligations, and that anything new must be in accordance with housing need and will need the support of the Council. As part of the potential development an extremely long extension to the playing field lease is envisaged. After discussion it was unanimously determined that the Parish Council will write in support of this application.
