Item 5. Minutes of the meeting held on the 20th July 2020

These minutes having been previously circulated, it was proposed by Cllr.Millidge and seconded by Cllr.Crate that they be accepted as a true record - **This motion was unanimously agreed**.

Item 6. Matters arising from the minutes of the 22nd June 2020

Street Lighting: The Chair has been in contact with Midland Sign and Lighting, and the Clerk is to ask E.ON when the streetlights were last cleaned.

Memorial Field hedge: A contractor is visiting Cllr.Millidge in the week commencing 23rd August 2020, and she will ask him for a quote to trim the hedge.

Playing Field; The Clerk will contact A.Khan of BTT& James to enquire about the lease for the field. Audit of Parish Paths: The Chairman noted that he has walked all the paths and they are passable.

The Chairman brought items 14 &15 on the agenda forward to accommodate the District and County Cllrs.

Item 15. County Council Issues.

The Chairman invited County Cllr.Crump to address the meeting.

Cllr.Crump reported that the County Council is getting back to normality with road gangs out repairing the roads, and that repairs to Stockton crossroads and the road to the Blue Lias will start in December 2020.

Stockton recycling centre will be opening in September and Cllr.Crump will give the details to the Parish Clerk when they are available, but it is likely to be on a booking system with Saturday and Sunday openings only.

Cllr.Crump noted that the library will reopen on 24th August 2020 but with a limited booking system in operation.

Cllr.Crump noted that HS2 must use signage to state that lorries are not allowed down certain roads, and when the public are telephoning to complain they must state that it is a complaint.

Cllr.Crump noted that some hedges are to be cut back and if there are any problems please let him know.

The A425 Southam to Napton road has a speed limit imposed of 50mph due to accidents,

There were no further issues from Cllr.Crump and the Chairman thanked him for his attendance at the virtual meeting.

Item 16. District Council Issues.

The Chairman invited District Cllr.Adam to address the meeting.

Cllr.Adam noted that any anti social issues with the playing field should be sent to him and he will forward them to the Community safety Team at the District Council.

Regarding the failure of HS2 consultations with parishes Cllr.Adam indicated that this should be better now but if there are further issues please let him know.

Cllr.Adam noted that there are potential and actual changes to the planning system with a training day set up for local government and that the Parish Council should be aware of the changes.

The national cycling group are looking to extend the cycleway to the Blue Lias (the old railway line from the cement works to Greaves cottages.
