

Minutes of the Monthly Meeting of Stockton Parish Council held in the Village Hall, Stockton, at 7.15pm on 18th June 2018

Item 1. Open Forum

Villager of the Year: The Chairman noted that it gives him pleasure that the award this year is given to Mr.and Mrs.Flegg for all their work throughout the village. He gave the Parish Council's best wishes to Mrs.Flegg for her husband Ron and hopes that he will get well soon.

Scout and Playing Field: Mr.M.Sharples gave an overview of the position of the scout field indicating that they were awaiting a response from Stratford District Council on the self-build project, but indicated that there is to date no timescale for this response. In regard to the position of the playing field, Mr.Sharples indicated that the views of the family had not changed, and that the field will continue to be a children's playing field in the future. In response to a question from the Chairman Mr.Sharples indicated that the family will approve a lease in order for the Parish Council to maintain and improve the facility, the Clerk was instructed to contact BTT& J to commence the procedure. In response to a question from Cllr.Millidge, Mr.Sharples indicated that future equipment could be allowed that is not directly associated with children.

Pavements: Mr.B.Legg commenced by apologising for his non-attendance at the last few meetings, but noted that the pavement outside the school is in a dreadful state such that a wheelchair cannot easily be pushed along, after discussion the Clerk will bring this to the attention of P.Byrne at the County Council. In addition, Mr.Legg noted that there was a need for dropped kerbs opposite manor Road, opposite the barley Mow, neither is there a dropped kerb in Earles Close, thus making access around the village difficult for wheelchair users, the Clerk will also raise these with P.Byrne.

Overgrown hedge: Mrs.Flegg raised the issue of the overgrown hedge at the entrance to Grange Farm Drive, it is unclear who actually owns the hedge, and the Chairman indicated that he will take the matter up with the County Council.

Drainage: Mr.Sharples indicated that there appears to be no surface water drainage opposite Station Road, with water lying on the road. This is a driving hazard that needs to be addressed. The Chairman will bring this issue to his meeting with the highways department.

Community Forum: The Chairman attended the meeting and noted that after some confusion the police priorities appear to be anti-social behaviour. Where highway faults are involved, the County Council indicated that they were marked either as urgent or non-urgent. Where an urgent fault is

listed, the contractor must complete repairs within 28 days, where a non-urgent fault is declared, the contractor can fit the work in as and when it can.

Item 19. County Council Issues

The Chairman brought agenda item 19 forward to facilitate County Cllr Crump. Cllr.Crump noted that for the next three months he will be the acting portfolio holder for Communities. The County Council has underspent last year by about £8M

A426 Stockton Crossroads: Cllr.Millidge noted that when coming across the junction from Long Itchington, although the verge has been mowed it hasn't been mowed far enough in the Dunchurch direction, and that fast-moving vehicles still cannot be seen early enough. The Clerk is to contact P.Byrne.

Playing Field: It was noted that wheelchairs cannot access the play area, the Clerk is to get M.Childs to put some slabs down to allow access.

Car parking in front of Barley Mow: It was noted that some cars are protruding into the road from the front, and as this is an obstruction of the highway, it then becomes a police matter.

Energy Saving: Cllr Warner noted that it would be a good idea for an energy saving company to address the issues of energy saving with the village. After discussion it was agreed that the best vehicle for this discussion would be at the Wednesday afternoon tea gathering in the village hall. Cllr. Warner will take the idea to the organisers of the gathering.

Hedge opposite Barley Mow: This hedge is owned by N.Clough who is responsible for cutting it back.

WI Bench: It was noted that the best place for this bench would be the green outside the school side entrance.

Wigley Group: It was noted that the Wigley Group are willing to give a tour of Kings House (for around 12 people) on 30th July 2018 and this will be added to the magazine and website

Gas sub station: It was noted that this sub station between the Nelson Club car park and the entrance to the sports club is now very untidy, the Chairman will determine ownership to have it tidied.
