### Minute Number 08 (22 - 23)

# Minutes of the Monthly Meeting of Stockton Parish Council Held in Stockton Village Hall at 7.15pm on 21st November 2022.

In the absence of the Chair, Cllr.Collerson, Cllr.Millidge the Vice Chair chaired the meeting.

The Chairman welcomed all to the meeting.

The Chairman brought forward agenda item 14, and 15 to accommodate Principal authority members in attendance.

### Item 15. District Council Issues.

District Cllr.Adam noted that the proposed new ward boundaries will now be sent to parliament for ratification, and this means that Stockton will now be paired with Southam East Central as the new ward.

Cllr.Adam noted that the matter of ID for casting votes has been raised by the District Council asking whether voting cards will be sufficient.

Cllr.Adam noted that the council tax budget for 2023-2024 is not yet known. Cllr.Adam noted that there is some financial assistance from the District Council for those who find themselves in energy need.

There were no further District Council issues.

### Item 16. County Council Issues

County Cllr.Crump noted that there have been thefts of equipment from the Fire and Rescue buildings in Southam, and that these thefts could undermine the ability of the F&RS to respond to emergencies.

Cllr.Crump noted that the F& RS is looking for more recruits. (firefighters).

Cllr.Crump noted that inflation is now impacting upon all contracts...

Cllr.Crump noted that he met with Severn Trent Water at Napton where STW detailed their infrastructure changes for the next few years.

Cllr.Crump noted that road traffic accidents seem to be mainly down to people driving under the influence of drugs.

Cllr. Crump noted that e scooters are illegal on pavements and roads (they are only legal on private roads).

Cllr.Crump noted that a Safer Neighbourhood team meeting on 24<sup>th</sup> November.

There were no further County Council issues.

The Chairman thanked both principal authority Cllrs. for their attendance.

### Item 1. Open Forum

The member of the public in attendance raised the point that the proposed self build east of jubilee fields is not in line with the results shown on the housing needs survey of 2021. It was explained that this development has been ongoing for a number of years now and that the Parish Council has supported it because amongst other things there will be a significant gain to the parish from this. The principal authority Cllrs. both noted that a defined number of self build sites is an integral part of the District Council local plan and that this is one of them.
