# The Chairman welcomed all to the meeting.

The Chairman brought items 17 and 18 on the agenda forward to accommodate the District and County Cllrs.

# **Item 17 District Council Issues**

The Chairman invited District Cllr. Adam to address the meeting.

District Cllr.Adam that the next pressing matter at the District Council is the proposed merger with Warwick District Council and asked that the Parish Council reply to the consultation document.

Cllr. Adam noted that there had been a meeting with the HS2 minister at which time the most pressing issues for this area were raised.

Cllr.Adam noted that the Boundaries Commission were conducting a review into possible boundary changes and urged the Parish Council to make its views known on the consultation document. The in reply noted that the preferred option for the parish Council would not be a link with Southam/Southam west, but rather a link with L.Itchington or Napton.. Cllr.Adam noted that the final outcome should be one that causes the least disruption.

Cllr.Crump noted that HS" was swallowing resources from other sectors e.g., materials, manpower (drivers) etc.
