Cllr.Crump noted that the late arrival of post is still a problem.

7. Cllr.Crump noted that the Aldi development is still ongoing with perhaps an opening in late November. The development is still awaiting Sec.106 agreements, and there will be safe "bus drop off and pick up points" incorporated in the development.

Cllr.Crump noted that there will be a CAB facility in the Grange Hall, Southam on Fridays.

Footpath from P.F. to Southam: It was noted that the ground is very muddy because of the hedge and ditch, however all public footpaths are the responsibility of the landowner.

It was noted that there are two potholes on the hill and one in Elm Row, the Clerk will report this to the highways department.

It was noted that walker's cars are being left by the church and the village green, it may be time for the Council to consider strengthening the verges or adding posts or flower tubs to the green.

R.Pundsack will sent an estimate for the repair of verges.

Grass reinforcement in George Street is being churned up and is obviously not suitable, perhaps it is time to consider a rolling programme to take up the soil, put roadstone and then a plastic reinforcement. This would need to be approved by the County Council.
