

**Minutes of the Stockton Parish Council monthly Meeting held in the Village Hall, Stockton, at 7.15pm on 21<sup>st</sup> November 2016**

Mr.Flegg indicated that there had been produced a road safety audit regarding the Napton Road development sites, but that he has been unable to obtain a copy of this from the planning website, and asked if the parish Council could obtain a copy. The Chairman replied that there was an original copy and it was either in the filing cabinet in the village hall, or stored at home, and that he will find this copy.

Mr.Legg pointed out that there should be a stop or halt sign at the junction of High Street and the Napton Road for safety reasons (to show definitively who has the right of way at the junction).

The papers were collected by the Clerk, and it was announced that Mrs. Helen Kittendorf was duly co-opted as Parish Cllr.

Mrs.Kittendorf signed the declaration of acceptance of office in the presence of the proper officer, and took her place with the other Cllrs.

### **Ongoing References**

*Community Forum:* It was noted that the Chair and Cllr.Banham will attend the next meeting on 30<sup>th</sup> November.

*Website:* Cllr Emberton gave an overview of the website hosting by Stratford District Council, and also the possible replacement by Hugo Fox who are offering free of charge hosting. Cllr.Emberton noted that he has already moved the petanque club website to this new host and that he will build another Parish Council website prior to any move from the DC website.

*Additional Street Lighting:* the Chairman noted that the light on the hill is covered by the adjacent tree thus cutting the light significantly. The Chairman noted that the Council may find it better to have a replacement programme to change all the lighting to LED's where possible. Cllr.Warner noted that the crossroads junction is too dark to be easily seen. The Clerk is to contact Sandra Townson of E.ON regarding this potential programme, and also whether a new taller column could replace the light on the hill.

*Housing development:* The Chairman has met with the site manager for the Napton Road developments who indicated that they are looking to start occupancy by April 2017 on the South side, and with the North site occupancy about 6 months later. The Grange farm site ditch will have to be moved, and a footpath laid to Grange Farm Drive, and perhaps extends the footpath to the FC-CC.

*Cemex Quarry:* Mr.Legg asked whether the Parish Council could lobby Cemex asking for wild flowers to be seeded on the banks adjacent to the road.

*Cemetery extension:* It was noted that we will have to move quickly to fence off an area of the extension that will not be in use for a number of years, the Clerk will contact Rick Frogley regarding getting a quote for the work together with a gate for access. The Chairman noted that that Farnborough Garden centre has some rowan trees for sale, and it was unanimously agreed that these could be purchased before Christmas. Cllr.Millidge noted that Hazel Grey would like to donate a pot grown horse chestnut tree, and this offer was gratefully accepted.

*Memorial Field:* The Chairman noted that the service of dedication will be on Sunday 22<sup>nd</sup> January 2017 at 10.30am. The Clerk will contact R.Mingins regarding turf.

The Clerk noted that Shipston on Stour have now started spray painting the offending mess, and this seems to be having some effect, the Clerk will contact the Shipston Clerk for details.

*Stockton crossroads:* Cllr.Warner noted that there has been another accident at the crossroads tonight and asked why is there no extension to the double yellow lines to past the junction in an attempt to mitigate these accidents. The Clerk will write to the County Highways safety team with this suggestion.

*Leaves on roads:* Cllr.Millidge noted that it is time for the road sweeper to take up the leaves before they clog the drains, the Clerk will contact Street Scene at the District Council.

*No waiting signs:* The Chairman noted that the purchase of these signs is now complete.

*Edge designs financial system:* It was noted that the proposed visit to Shipston on Stour Town Council to view live system will take place on Tuesday 29<sup>th</sup> November.

Cllr.Emberton gave his apologies for absence for the next two meeting as he will be in Australia.

There being no further business the Chairman closed the meeting at 9.10pm.
