**Minutes of the Annual Meeting of Stockton Parish Council
Held in Stockton Village Hall at 8.25pm on 21st July 2025.**

The Chair welcomed all to the July 2025 Monthly Meeting of Stockton Parish Council

Item 1. Open Forum

A member of the public gave an update on the state of the village hall floor and noted that some rot had been found, some remedial work has been carried out but further work is now necessary. The village hall committee has applied for a grant from the heritage lottery community fund for a total of £20,000 and hope to hear from the fund fairly soon, however if this bid for funding fails then some significant fund raising will be required. A contractor has repaired the part of the floor that was rotten and the floor is now safe to use by members of the public, the contractor will review the whole of the floor to ascertain what further remedial work is necessary.

The Chair brought agenda items 17 and 18 forward to accommodate the Principal authorities member present

Items 19 and 20. CC and DC Issues

Cllr.Crump noted that Stratford on Avon District Council's land supply figure is under threat by developers at a public enquiry and if upheld could pose significant problems for the district in terms of house building, but to date no decision has been made by the inspector on the matter. It is noted that under the revised method Stratford DC now has a 5.6 years worth of land supply.

A joint submission by Warwick DC and Stratford DC has been made to central government regarding the shape of the proposed unitary authority/s for this county. This submission argues that there should be two authorities for the county with a size of 250,000 each, but the County Council's submission is for only one overall authority. With two authorities there could be problems with cross border jurisdictions for the F&RS and that two authorities would be relatively small. Rugby BC does not want to part of either of the two proposed authorities rather it favours one overall authority.

Cllr, Crump is waiting to hear the results of be a feasibility study into Stockton crossroads by WCC. Cllr,Crump is willing to ask on the Parish Council's behalf for funding to have an independent road safety audit for the area.

The cycle lane from Southam to Long Itchington is ongoing with possible options for Southam to Stockton to be tied in,.

Southam Fire Station is now manned full time during the day with a new appliance.

Cllr,Crump noted that a major application for Napton Brickworks of 100 dwellings may impact upon Stockton

This ended Cllr. Crump's report and the Chairman thanked him for his attendance.
